Annexure to guarantee line agreement with HSBC Bank Polska S.A.

Message:

The Management Board of Fabryka Obrabiarek RAFAMET S.A. in Kuźnia Raciborska informs that today the company received signed by HSBC Bank Polska S.A. (00-693 Warszawa, ul. Marszałkowska 89) annexure no. 4 dated 26.03.2012 to the Guarantee Line Agreement dated 14.10.2009.

The agreement covers guarantee line amounting to defined limit which on the base of the annexure no. 4 to the Agreement has been increased from 3,000,000.00 EUR up to 4,000,000.00 EUR (16,563,600.00 zł), meeting the same the value criterion for significant agreements.

The issuer can use the limit for the following purposes of guarantees: tender bonds, advance payment bonds, performance bonds, warranty bonds and mixed bonds. The limit availability has been defined as of 29.05.2015. The guarantee line is secured by transfer of dues from the contracts accepted by the bank.

The subject agreement has been concluded under market conditions which do not differ from those commonly used for such a kind of agreements.

The RAFAMET S.A. company shareholder's equity as of 31 December 2011 has been taken as a criterion for significant agreements.
